

Your application was selected by the U.S. Dept. of Education for review in a process called “verification.” In this process, we are required by federal law (34 CFR, Part 668) to compare the information from your application with the information provided on this form and with signed copies of your 2008 federal tax forms. You must submit a signed copy of your spouse’s taxes if you are married or your parent’s signed taxes if you are considered a dependent student. If there are differences between your application and the documents you’ve submitted, corrections may need to be made. We cannot process your financial aid until verification has been completed, so please provide the required documents as soon as possible.

What you should do:

1. Collect your (and your spouse’s or parents’) financial documents (**signed** 2008 Federal income tax forms, W-2, etc.).
2. Complete and sign the worksheet - you (and your parent if you are required to provide their income information).
3. Contact us if you have questions about completing this worksheet.
4. Submit by mail, fax, or in person the completed worksheet, tax forms, and any other documents to our office.
5. We will compare the information on these documents and make corrections if necessary.

If you did not keep a copy, call the IRS at 1-800-829-1040 to request an official tax transcript and wage statement. Press 2 (Personal Tax Account), Press 2 (Personal Tax Account), Enter your tax payer ID number (SSN, ITIN, EIN), Press 3 (Transcripts), Enter the numbers in your street address, Press 2 (Transcripts), then enter the year of the return you are requesting (i.e. 2008).
